### **GUIDE TO 2012 APPLICATION FOR \$1,000.00 SCHOLARSHIP**

*(A minimum of 5 scholarship will be available this year)*

**Deadline:** Completed Application with all Attachments is to be **Postmarked** by February 20 (**N.B.** Late or incomplete Applications will not be considered or returned.)

**Eligibility:**

1. Meritorious High School Seniors with full or partial Italian ancestry.
2. Students at any public or private high schools in Sarasota County, those in Manatee County, south of the Manatee River. (Bayshore, Bradenton, Braden River, Lakewood Ranch, Manatee, and SouthEast ) and Lemon Bay H.S.
3. Minimum overall unweighted Grade Point Average (GPA) of 3.50, and
4. Minimum SAT combined of 1200 or ACT composite score of 25.

**Bases for Scholarship Award** (Listing order not reflective of priority or factor weight).

Academics: GPA, and SAT or ACT scores, as specified above.

Essay - 500 word maximum – See App. Section (E) for Topic and directions.

(Submissions become the property of GCICS. They may be edited, published or disposed as the GCICS sees fit. Applicant may be asked to read his/her submission at the Award Ceremonies.)

School and Community Involvement, including work experience.

Italian Heritage: Lineage factors of affected applicant's Italian roots may be rated to resolve tie among eligible candidates.

(Applicant **NOT** disqualified due to receipt of financial aid or other scholarship).

Finalist must participate in a personal interview by selected committee members, prior to the final award determination. Successful applicant must also commit to attend the GCICS Gala Award Ceremonies.

Scholarship funds will be mailed directly to the Bursar or other official of the chosen educational institution, with instructions that such funds may be used for any expense processed through such Bursar or other designated financial official.

All Applicants should be aware that Scholarship funds shall not be disbursed to any educational institution until the **GCICS** Scholarship Committee Chair is furnished a copy of the acceptance letter from the selected institution of higher education. The successful Applicant must also provide evidence of registration bearing Student ID Number, and of a full-time class schedule at such institution at the beginning of the term that starts immediately following high school graduation, as well as the contact data for the Bursar or other official to whom the check is to be sent.

Unused scholarship funds must be returned to the **GCICS**, c/o the Scholarship Committee Chair, if:

- a. The Scholarship Recipient ceases to attend classes, irrespective of reason:
- b. The Scholarship Recipient withdraws from school, or
- c. Recipient does not fully expend the Scholarship funds.

Should the Scholarship Recipient choose to attend a school other the one originally selected, or having commenced study at such school decide to transfer to another accredited institution of higher education, the Scholarship Committee Chair, must be notified, immediately, so that the balance of the funds may be transferred accordingly.

**Any funds returned to GCICS that are not transferred to another school will, at the discretion of the GCICS, be awarded to an alternate applicant or used for future awards.**

Remember, the review of your application will be facilitated by its neatness and legibility.
